Dear Parents,

The Management of Ryan International School, Dombivli has resolved to declare the standard-wise fee structure before the commencement of admissions for the academic years 2026-27 and 2027-28 to ensure transparency and allow parents ample time to plan for the upcoming academic terms. This declaration aligns with the provisions and procedures prescribed under:

- The Maharashtra Educational Institutions (Regulation of Fee) Act, 2011
- The Maharashtra Educational Institutions (Regulation of Fee) (Amendment) Act, 2018
- The Maharashtra Educational Institutions (Regulation of Fee) Rules, 2016

The fee structure applies to students from Mont 1 to Grade X for the academic years 2026-27 and 2027-28. Please see the details below

Remark: The revised fee will be applicable for two academic years, i.e., 2026-27 and 2027-28.

The following fees will be applicable and charged for new admissions:

- Registration Fee (Non-Refundable)
- Admission Fee (Non-Refundable)
- Admin Fee (Non-Refundable)

The school management has decided to offer two modes of payment:

- Full Payment (with a 5% discount, valid until March 15, 2026, for AY 2026-27 fees, and March 15, 2027, for AY 2027-28 fees)
- Monthly Payment through Gray Quest or any partner duly identified

\*Additionally, an Annual/Sports/Event fee of Rs. 2750/- will be charged separately.

Above Fees Includes: Class Photo, Field Trip, Health Check-up, Student Dairy, Parent App/Portal, Student & Parent ID Card, Science Experimentation Kit, Innovation Lab etc.

Exclusions in the above Fees which are not limited to "Optional" - Transport, Club Activities\*, ASSET/Olympiad, After School Activities & School Excursions, Picnics etc.

Exclusions in the above Fees which are "Mandatory" - Books & Stationery, School Uniform, Annual Day / Sports Day/Events, CBSE Exam / Registration fee for Grade 9 and 10

\*Club Activity Includes (Optional) not limited to - Coding, Entrepreneurship Program, Financial Management, Career Counselling, MUN, Young Directors Program, Young Journos etc.

Fees has to be paid by completing the sign up process on our payment partner portal "GrayQuest" or partner duly identified at the time of Admission, whereas Monthly instalment deduction will begin from the bank account authorized by the parent every month starting from March.

Please note that failure to pay fees as per the schedule will be considered as a sign of the parent's unwillingness to continue the student's admission. This may result in the cancellation of the admission in accordance with the order in Civil Application No. 914 of 2018 in Writ Petition No. 9444 of 2017 in the High Court of Judicature at Bombay.
