POCSO ACT, 2012

- Definition of a child
- It is a special Act.
- Proof of burden on accused.
- It is gender neutral.
- Police cannot refuse for an FIR – 0 FIR
- Special courts and special public prosecutors
- Child Friendly
- No Release of Information of the child/ institution to Media
- Compensation
- Age of Consent

Juvenile Justice Act – Procedures

Below 7 are not liable for any offence they commit.

Between 7 to 12 may be held liable (reform and rehab.) for an offence if the JJB observes they had sufficient maturity to commit the crime.

Between 12 to 18 are liable (reform and rehab.) for the offence.

Between 16 to 18 is liable for punishment as an adult provided it is proved that he has mental capacity to understand the consequences of his/her actions. This change came after the Nirbhay – Delhi Gang Rape in 2012 & subsequent Mumbai Mill Gang Rape.

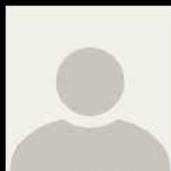
